Sponsorship Guidelines

These guidelines provide prospective applicants with information about financial assistance from the Shire of Augusta Margaret River by way of Sponsorship.

Please read these guidelines carefully before submitting an application. You may direct any questions to the Shire by email on amrshire@amrshire.wa.gov.au or phone us on 08 9780 5255.

Funding available

The following sponsorship funding is available:

- \$200 for National representation
- \$500 for International representation.

Eligibility - Who can apply?

To be eligible for sponsorship the applicant must meet the following criteria:

- Be an enrolled student at a primary or secondary school within the Shire of Augusta Margaret River
- Be a member of a local school, sporting association or club selected for State or International representation.

Funding will be considered for

- Students, individual or teams who are required to provide their own travel, accommodation and uniforms for the event / competition.

Funding will not be provided for

- Individuals who have selected themselves to attend an event / competition
- Individuals who are not a member of a local school, sporting association or club
- Activities that are already covered by an existing service agreement with the Shire of Augusta Margaret River.

F112.1 SPONSORSHIP

Restrictions on funding

- Only one application per financial year (July to June) may be lodged
- Athletes or performers are not to have received a payment of any kind from another funding source for their participation in the event or competition
- Applications are to be lodged on the Shire's official application form and retrospective applications will not be considered where they are submitted after the event or competition.
- Where applicants are under 18 years of age the application form is to be signed by the representing educational institution, committee member of the sporting association / club or parent
- Where applicants are over 18 years of age the application form is to be signed by a committee member of the sporting association or club
- Selection letters or emails for the event / completion are to accompany the application form.

Application timeframes

Applications are accepted at any time during the year.

Completing and lodging your application

Once you have completed all sections of the form and signed the declaration, please take a copy for your records. The Shire requires the original, signed application form be submitted by either of the following methods:
